## OPEN DATES: April 24 - October 12

### **CHECK-IN/CHECK-OUT**

- There is no formal check-in/check-out policy.
- Camping permits are valid from 2:00 pm on the first day of stay, until noon on the last day of stay. Early arrivals are permitted if approved by Campground Supervisor and site is available.

## QUIET HOURS ENFORCED 10 p.m. to 6:00 a.m.

### **FEES:**

Non-electric sites	\$30.00
Electric sites	\$40.00
Daily Launch Fee (for non-campers)	\$5.00
Overnight Parking/Storage	\$5.00
Non-registered camper shower	\$5.00
Non-registered camper dump fee	\$5.00

<sup>\*</sup>No refunds for early departure, inclement weather, water levels etc.

#### **CAMPING UNITS:**

- One camping unit (tent, RV, camper) allowed per site, unless otherwise approved by Campground Supervisor.
- Tents may be set up on grass.

### **SITE OCCUPANCY:**

- No more than 2 vehicles allowed per site.
- Maximum site occupancy is 6 persons, unless otherwise approved by Campground Supervisor
- If site is not occupied by noon on the 2<sup>nd</sup> day of reservation, and notification has not been given, WVIC reserves the right to terminate reservation.

#### **FIRES:**

- Permitted in fire rings only.
- Must be attended at all times.
- Do not move fire rings.
- Firewood collection not permitted.
- Only DATCP-certified or firewood harvested within 10 miles of campground may be brought in.

#### **PETS:**

- Must be kept on a leash.
- Pick up, bag and dispose of pet waste in garbage dumpster.
- Small dog fences for daily campers *may* be allowed on a case-by-case basis but must be approved by campground management.
- Electronic dog fences are not allowed.

## **USE OF WATER AND SHORELINES:**

- Boats may be moored on shoreline below campsites.
- Shoreline areas and paths are considered open areas available to all guests.
- Use the shoreline areas and water at your own risk, there are no lifeguards.

### ATVS/UTVs:

- Must remain on truck or trailer while inside the campground.
- Overflow parking and ATV/UTV trailer parking is available in east parking lot for \$5.00/night.

#### **VISITORS/NON-REGISTERED GUESTS:**

- Except for the boat launch, use of any campground facilities by non-registered campers is prohibited without Supervisor approval.
- Day visitors allowed for registered campers. No formal check-in required for visitors.

### PROHIBITED IN THE CAMPGROUND:

- Operation of minibikes, off-road vehicles, ATV/UTVs and golf carts.
- Fireworks.
- Children in fish house without adult supervision.
- Solicitation.
- Inflatable figures.
- Discharge of firearms, including BB/Pellet guns.
- Displaying of firearms except for cleaning and/or transporting to/from vehicles.
- Metal detecting.
